## Product Limited Warranty

### EXCLUSIVE REMEDIES

**HBF-CP's and Seller's sole and exclusive liability, and the sole and exclusive remedy for any loss or damage arising from the purchase or use of the Product shall be a refund of the actual purchase price of the Product or replacement Product.**

The duration of the warranty on any replacement Product will not exceed the balance of the warranty remaining on the Product that was replaced as of the date of such replacement.

### WARRANTY CLAIM PROCEDURE

In order to qualify for the remedies described above, the claimant must notify HBF-CP, in writing, within thirty (30) days of discovering the allegedly defective condition. Claimant must provide proof of purchase of the Product which is alleged to be defective and covered by the foregoing warranty.
